### 4. Updates

**North Uttlesford Garden Community** Hinxton Parish Council and individual residents have submitted their objections. Approx 80% are against this development.

Uttlesford District Council approved the revised version in October. Grosvenor Estates have asked for meetings with local PCs however they have nothing new to show us and it was doubtful if this was proper behavior. UDC are still proposing to submit plans in Jan 2019 and a decision made by Autumn 2019.

Wellcome Trust Development. Final consultation with developers was held at the Genome Campous in October. The application is expected to be in late Nov, there will be a 30 day consulation period, SCDC have encouraged Parish Councils to ask for more time, we hope to hold a meeting in the Village Hall after Christmas with Wellcome Trust, so that villagers have a formal meeting and chance to ask questions. Tom Clarke was invited to this meeting but he was away. WB to ask other Parish Councils if they have asked for a meeting.

An informal meeting of Councillors was held to discuss possible objections to the application, which is expected to be massive our objections should not be in variance with the objections raised for Smithson Hill Agri Tech proposal.

Main objections will be the number of homes to be built, character of landscape destroyed, Traffic Management, environmental impact and amenities which villages could use.

**Iron Bridge** – Nothing heard from Wellcome Trust yet, this will be raised at the next Liason meeting with Wellcome. Still waiting for Wellcome to approve funding. One barrier has been removed causing a potential Health and Safety risk.

**Allotments** – There is one spare allotment. An advert should go in the next Hinxton News. Emails will be sent out to collect next years rents. Water bill to be paid when we receive the bill from Village Hall Committee

**Smithson Hill AgriTech Park** An appeal has been lodged, our response has been sent in, local PCs have also sent their responses. The hearing is due in Spring 2019, we will continue lobbying against this development.

**Playground report** – Several minor jobs have now been done- noughts and crosses, train and the standing board. The basket swing needs a repair, The company that installed this will do th

repairs under warranty.

A work party was run to tidy up the playground

Flint wall/Village Hall/car Park repairs - quotes are still being obtained, First quote received was £16,000. Wellcome Trust have kindly agreed to donate £2000 towards this. The Community Chest which we have obtained grants from in the past, has now been changed so that only villages with less than 160 residents can apply for it. Peter Topping suggested writing to them and put our case for applying for a grant as we such a small village.

An advert will be put onto the Next Door Hinxton website to ask for quotes

**Genome Campus Liaison committee** –. Barbed wire round playground, we will ask Martin if he can help to get this sorted. The new trees in Knights Close have died, these to be replaced. Footpaths, we have been told that the permissive paths will be cut in Week 1 June and week 4 August. Water meadows- next year farmer from Thriplow will put his cattle and sheep here to graze the meadows.

**Defibrillator** This has now been delivered, to be put in the porch of Village Hall. Exact position to be decided, needs electric supply as the cabinet is heated.

Wetlands Conservation Committee- clearing of reed beds delayed, programme of walks to be scheduled for next year.
