Updates- Ford, Problems persist with the gates not being opened and shut in timely manner. Still no concrete pathway around the gate at Duxford End

Flooding now appears to be sorted at both ends of village.

Footpath renewal near Village Hall, still no date set for this work to be done.

Wellcome Trust Liaison Meeting. Plans for the proposed new building applied for were discussed, hedge down Ancient Lane to be cut hopefully in Feb/March.

Mileage allowance set at 20p per mile to cover costs of Councillors travelling on Council business.

Parish Planning Training sessions to be held at Sawston Village College. Clerk to attend.

Village Hall painting exterior, Clerk to obtain 3 quotes for exterior woodwork, ST to discuss with Village Hall Comm, if they had thoughts on the brickwork being painted as well

Support for Natural Cambridgeshire Group. Agreed to support, ST offered to represent PC if required.

Hinxton Website, JB had looked at this, BT offered free website for Community bodies, it will soon be a legal requirement to publish full Minutes on a Villages Website and it would also be a good place to make Hinxton residents aware of any interesting or useful information which is regularly received but too long for the Newsletter.

New Councillors training for coming year booked.

Precept set at £10350 for next financial year

Final sum given by Parish Council to re-roofing of Village Hall was £2512. Village Hall Com paid £580 towards the Insulation.

Allotments. All rental fees now received

Superfast Broadband, this should be rolled out to Hinxton between Sept and Dec 2015, details on the Connecting Cambridgeshire Website.

## **Chairmans' report .**

ST to stand down as Allotment representative, WB offered to take over this role from now on.
