Date for next years clean-up to be earlier in the year before verges grew too much. Clerk to contact McDonalds to thank them for picking litter along the main road as this is now much tidier.

New Parish Councillor, Dick Brown attended the meeting and is interested in joining the Council, this will be voted on at the next meeting.

Level Crossing work plans- these shown to Councillors, plans are to make the Crossing safer by installing gates at full width and also sensors to warn if any obstacles on the line.

Website progress – now up and running. JB to look into acquiring a Hinxton domain name to make it more accessible, rather than as a link from another website.

Bridges- inspections,& repair fund, Clerk to look at getting these inspected and possibly insured.

Wellcome Trust Liaison Meeting, the Willow tree by the Mill has now been cleared, Knights Close has been cut, some reports of Ash trees having die-back but they are all still growing, this will be monitored. Lordship Farm soon to be completely renovated. Next meeting 2nd Sept.

Footpaths grass cutting- Clerk has contacted Bidwells but no-one has responsibility for cutting the permissive paths. Clerk to contact our contractors to see if this can be added to their work and also County Council re cutting of Public footpaths.

Section 137 donations, charities this year will again be East Anglian Air Ambulance £200, and Bobby Scheme ,£50,which helps Victims of Crime and also works towards crime prevention.

Beekeeping problems- there have been reports of problems with bee swarms, Tony Orgee to look into any laws and regulations which may cover this.

Grand re-opening of Wellcome Trust Conference Centre 5th Oct 2015 – Parish Councillors from local villages have been invited, Clerk has sent names to the organiser.

WT trust talk booked for September 3rd, 2 talks covering the work that is done, collaborations with hospitals and also the nature and archaeology of the site.

Flooding Consultation- Clerk has replied to this to say that rivers need managing better, eg dredging and reed clearance. Some work has just been done to kill off some of the reeds.

Signs are to be put up around the village showing the Police crest,CDC logo and Smartwater logo, this is regarding the Police initiatives in Crime prevention especially home security.

Insurance – Clerk has met with Insurance broker and quotes will be sent nearer to renewal date. The Broker suggested that regular Checks to be put in place for checking playground and
